OUR MISSION

The Funny Flame revolution: FFL

Our team's goal is quite clear, we literally want to burn the top memecoins around. We are tired of this primacy of machomemes and we also want to give women some space on the crypto-Olympus.

We will build a strong community through widespread and strong marketing on the main communication channels and we intend to gradually increase the capital available to make Funny Flame known to the whole world.

We want to have a coffee with Pepe and Shiba, and maybe oust them from their podium. It won't be an easy challenge but we will try hard. Following the first steps such as pre-sale and listing, we aim to bring Funny Flame to the main Cex and dramatically increase its visibility.

Not only that: following the presale, part of the liquidity will immediately be invested in marketing and the warmth of Funny Flame will radiate to many social channels known to you. Who knows how hot it can be in the Tube! We want to bring the best-known names in the industry into our circle of influencers. Twitter, Youtube and Telegram will be ours.

Once landed on the Cex tier 1, the project involves the development of merchandising and the Funny Flame brand. Fans will be able to wear funny flame, enjoy a coffee in the Funny Flame cup (we're sure it won't cool down that quickly) or warm up under the Fanny Flame blanket.

Hand in hand with the development of merchandising we will try to reach our large objective: 100 million market cap.

Ready for the revolution? Buy it. Fire it. Burn it!

TOKENOMICS

Our team tried to develop the optimal division of resources in order to give balance to the project.

45% DEX AND PRESALE

This will be the liquidity that will be added to Pancakeswap, available for trading, and the liquidity that will be sold in presale on Pinksale.

10% CEX LIQUIDITY

These tokens will be used for the subsequent launch of Funny Flame on the Cex and allow our project to become truly global.

10% PROJECT DEVELOPMENT

This liquidity will allow us to develop the more advanced stages of the project, as specified on the other pages. We will also need it to reach the top 10 exchanges.

20% BURN

In line with the philosophy of our entire project we reserve the right to burn a percentage of the tokens to support the chart.

The quotas dedicated to the burn will be divided into packages locked for different periods. 3% of tokens will be burned at launch. Two more packs of 7% and 10% respectively will be unlocked later and burned gradually.

5% PARTNERSHIPS

We will use these tokens to develop partnerships that will allow us to increase the visibility of our project.



5% AIRDROP

These tokens will play a vital role in building our name and fame.

They will serve to give voice to our little flame in the early stages of its birth.

The lucky ones who manage to grab our airdrops through Twitter could perhaps find themselves with a fortune in their hands, and what's more, for free! These tokens will be blocked and distributed only at the time of listing on the CEX.

5% TEAM LOCKED LIQUIDITY

Yes, here we are. Like any good project, this one will pay off its founders only at the end. In fact, the liquidity will be blocked for two months, and will allow Funny Flame to grow peacefully.

We are the first to believe it!

SMART CONTRACT

Kyc and smart contract audit to ensure transparency of the project.

COMMUNITY BUILDING

We are working on building a large and close-knit community on Telegram and Twitter, but it is only the beginning of the journey as we want to extend our presence to all other communication channels with particular focus on YouTube and TikTok.

MERCHANDISE

We will develop the brand.

This step will be part of the advanced stages of the project as a widespread diffusion of our brand will be necessary in order to create a reference market for our products.

A profit sharing program will be developed with our community, based on token holding.

We will develop marketing towards the clothing sector and in general also outside the crypto segment.

TOKEN LISTING

the listing on dex will be done immediately after the end of the presale on pinksale.

We estimate that soon we could list our tokens also on the first Cex and begin our climb towards fame.

MARKET CAPITALIZATION GOAL

Our stated goal is to bring the value of our token to a capitalization of \$100 million. It won't be an easy challenge, but we will give it our all.

Furthermore, it is not guaranteed that this capitalization will be enough for us, it will depend on the speed with which we are able to reach this value.

If possible we will continue to push the graph up.

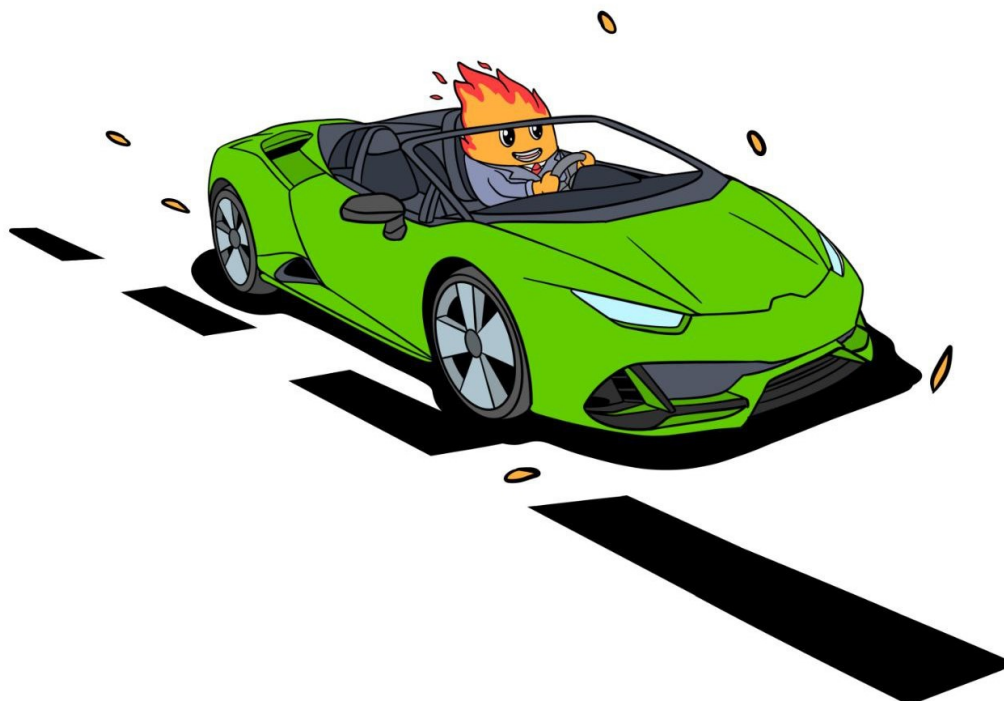
